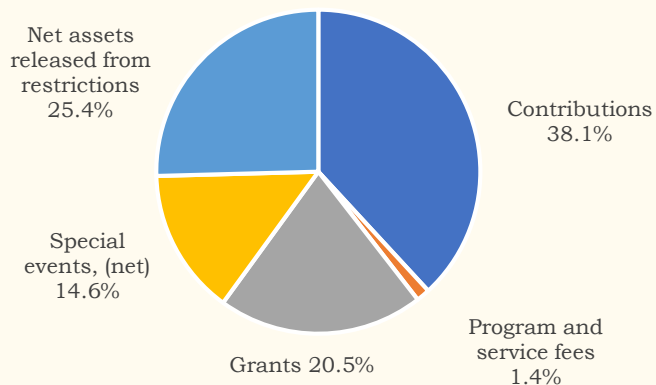

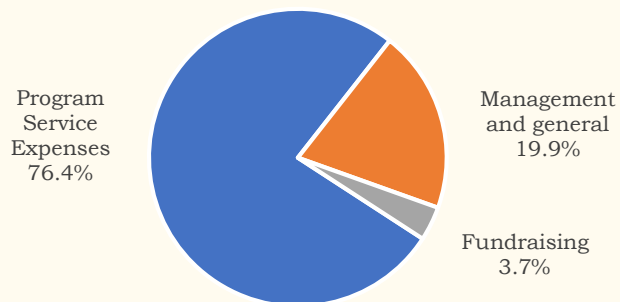
Statement of Revenues, Grants and other Support and Expenses
